## **Job Description**



# Manager, Data Risk

The role is essential in improving the governance of data-related activities with a primary aim of identifying, managing and reporting on data risk at Carnival UK. The role holder will work alongside the Director, Privacy, Data Protection and Risk Management to monitor issues that impact the effective handling and use of data, and to investigate and document contributory factors of these issues in order to develop a sustainable programme of improvement.

The Manager, Data Risk will be an initial contact point for data users from around the business and will contribute to, implement and monitor embedded data quality and retention processes, orchestrating a network of data stewards and working groups, and contributing to the development of solutions to treat known risks.

#### Accountabilities

- In collaboration with the Privacy & Data Protection function, act as a point of contact and escalation for data governance and risk management queries for Carnival UK.
- To participate in investigative activities and maintain detailed documentation relating to data-related issues, identifying contributory factors and raising well-formed risks to the data risk register.
- Maintain an up-to-date and accurate data risk register in conjunction with accountable risk owners and subject matter experts, clearly categorizing risks, and regularly updating the status of risks and impacts.
- Produce a regular reporting pack on data risks and treatment progress to stakeholders at a specified cadence.
- Own and operate the process to govern personal data on unstructured storage, raising exceptions with Data Stewards and driving improvements in the areas of data ownership, management and retention.
- Report agreed metrics and KPIs from the unstructured storage management process to stakeholders at a specified cadence.
- Maintain an active network of Data Stewards, cascading ways of working and best practice and capturing new risks and concerns raised from their business areas.
- Through appropriate subject matter expertise, communicate strategy, requirements and improvements to stakeholders.
- Promote a culture of responsible data governance and best practice throughout the organization.
- Participate in the development and promotion of policy and standards
- Lead targeted working groups and initiatives to develop solutions that improve efficiency, effectiveness and quality
  of data governance.
- Support formal committees and related processes relating to data governance, such as capturing and sending out minutes, and maintaining decision and action logs.

#### Health, Environment, Safety, Security (HESS) Responsibilities

- Key participation in the development of solutions that drive compliant, efficient and effective data processing.

- Work closely with stakeholders to clearly link known risks to data requirements, supporting business cases for change.
- Strong reporting skills tailored to the intended audience.
- Able to work independently on own initiative, within agreed boundaries.

#### Leadership:

- Have excellent planning, prioritisation and organisation skills, effectively identifying and managing milestones across multiple projects and stakeholders.
- Lead the investigation of issues and influence stakeholders throughout CUK to develop sustainable solutions.
- Identify, implement and embed new ways of thinking and working and bring others along on the journey.
- Promote a culture of good data governance throughout the organization.
- Manage stakeholders at all levels and across the business to influence change and hold them to account.
